From Benchwarmer to Board Member... Strategies for Effective Board Involvement and Governance

David Strege is a Senior Fee-Only Planner at Syverson Strege in West Des Moines, Iowa and has been providing guidance to individuals about personal finances since 1981.

David earned a B.S.B.A. in Finance with a concentration in personal financial planning from Drake University. He earned his CFP® certification in 1982 and in 2008 served as Chairman of the Board of Directors for the U.S.A. Certified Financial Planner Board of Standards Inc. In 1987 he received the Chartered Financial Analyst® certification to better assist clients with their investment portfolios. He earned the Certified Kingdom Advisor® designation in 2017.

He has served the profession by being on the National Boards of the Financial Planning Association and Certified Financial Planners Board of Standards. While he was Chairman of the CFP Board in 2008, he traveled to other CFP countries to make sure the standards were consistent worldwide. David spoke at the FPA of Singapore's conference, the CFP Professional International Forum in Christchurch, New Zealand and China's first Financial Planning Conference in Shanghai. David served on the Board of Directors for the National Endowment for Financial Education® (NEFE®) for nine years and served as Chairman in 2018.

He received training in policy governance over the years. He has helped churches, non-profits, for profit and his own financial planning firm to implement policy governance.

David and his wife, Jennifer, live near Winterset, lowa, have two adult children and all the family members are avid volleyball players. Jennifer and David still medal in volleyball at a national and international level. They attend Lutheran Church of Hope.
